Section 1:

Members:

There shall be Two (2) classes of members; FULL MEMBER and ASSOCIATE MEMBERS

section 2:

Full Members:

Full member shall be those who satisfy the following requirements:

- Should be qualified Clinical Oncologists* as defined in Section 2 of Article-1
- Should hold the qualification of FCPS, FRCR, DMRT, MCPS or American Board of Radiation Oncology or Equivalent as recognized by PMDC

OR

- Oncology, Hematology, Hematologic Oncology, Pediatric Oncology, Nuclear Medicine. Individuals who hold major qualifications in allied disciplines including Medical
- Should be in active practice in any aspect of Clinical Oncology or allied disciplines
- Should have the credentials approved by the membership committee.
- medically qualified person professionally engaged in the management of patients who have The word clinical oncologist used in this constitution means "A Clinical Oncologist being a cancer using radiation and other appropriate methods of treatment".
